

35 Highway Miles Added to Total In 3-Day Period

Thirty-five miles of interstate highway, built at a cost of \$18.8 million, were added to Michigan's growing freeway system during a three-day period recently.

New sections of freeway completed and open to traffic include: — 2.9 miles of Interstate 94 from Jackson east to the Jackson-Washtenaw county line. — 21 miles of Interstate 75 (U.S. 27) from north of Indian River to Mackinaw City. — 41 miles of Interstate 75 (U.S. 27) from the Mackinac Bridge north to Castle Rock.

STATE Highway commissioner John C. Mackin participated in special ceremonies marking the opening of all three sections. Michigan's longest continuous stretch of freeway was increased from 121 to 156 miles with the opening of Interstate 94 east of Jackson. The freeway now extends from the Jackson-Washtenaw county line west to St. Joseph on Lake Michigan.
