**AFTER A** honeymoon at Cape Cod, the newlyweds will make their home in Ann Arbor, where they will continue their studies at the University of Michigan.

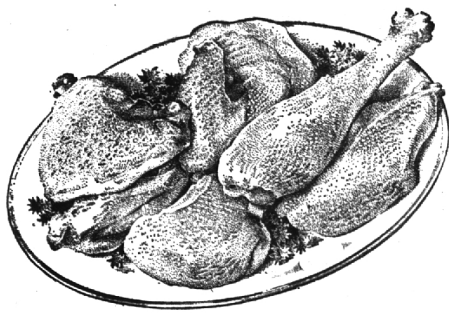
## MSU Student's Troth Revealed
