CITY OF BIRMINGHAM ORDINANCE NO. 564

AN ORDINANCE TO AMEND SECTION 5.7 OF ORDINANCE NUMBER 527 OF THE ORDINANCES OF THE CITY OF BIRMINGHAM

Section 1. That Section 5.7 of Article 5 of Ordinance No. 527 be amended, said Section to read as follows:

- A. No accessory buildings shall be erected in the front or side open space.
B. Accessory buildings may occupy a portion of the rear open space and shall be at least three (3) feet from all adjoining lots except as otherwise provided therein.
