

New Bill A Burden, Says Yntema

A law barring automobile manufacturers from financing and insurance activities would cost car buyers from \$50 million to \$100 million a year, said Ford vice president T. O. Yntema, 3860 Franklin, Bloomfield Hills.

"The burden of higher finance and insurance costs would fall mainly on car buyers with low incomes who cannot borrow from banks," he said.

YNTEMA TESTIFIED before the Attorney Subcommittee of the House Judiciary Committee against a bill that would prohibit any automobile manufacturer from providing financing or insurance in connection with the sale of its cars.
