

Police Prevent 3 Burglaries In Southfield

SOUTHFIELD—Alert police prevented three burglaries during the last 10 days in Southfield.

On Sunday at 12:12 a.m., David Erickson, a Southfield resident and employee of the Crainco Sales and Mfg. Co., 19240 W. Eight Mile Road, was awakened when he returned to the building on business with a friend, Richard Pennala.

Seeing a man upstairs, Erickson sent Pennala to call police. An Okla. Park officer, passing by, stopped when he saw Pennala running out of the building. The officer apprehended and arrested William Valler, 30, of Hazel Park, who had meanwhile run out of the side of the building.

Entry was made through a window on the east side of the building. Southfield Officers Clayton Rahn, Don Harding and Ronald Roediger and Sgt. James Harvey also responded.

OFFICERS HOWARD Willis and Raymond D. Pinea apprehended Frank Capobianco, 27, of Madison Heights and Donald A. Holden, 29, of Detroit at the home of Ethel Goldstein, 18501 Ten and One-Half Mile Road on April 27. Entry was made through the rear of the home.

ANOTHER BURGLARY at Town Drugs, Greenfield and Edwards was prevented at 2:30 a.m. April 24, when Officer Richard Wort discovered two men on the roof of the building while he was making a routine check. Wort radioed for help and pursued the men who had jumped off the roof. They fled into a field behind the drug store.

Sgt. James and Officers Ronald Foster and Harding responded to Wort's call. A warning shot was fired but the men escaped. Southfield police said several other area police departments also responded to the radioed call for assistance.

VALLIERS was arraigned in Southfield Municipal Court Monday and bound over to Circuit Court for arraignment next Monday. He posted \$2500 bond.

Bolden's bond was set at \$2,000 and Capobianco's at \$1,000, pending examination in municipal court on May 19 at 9:30 a.m. They were arraigned Friday and stood mute.

The court entered a plea of not guilty against the two men.

SOUTHFIELD—A request for a neighborhood shopping center, approved by the city's planning commission, has drawn objections from the Cranbrook Village Home Owners Association.

A representative of the group appeared before the council at a public meeting and complained that there are now three shopping centers within a two-mile radius of the subdivision's outer borders and therefore no need for another.

The subdivision is located between 12 and 13 Mile roads and Southfield and Evergreen roads. The proposed center would be located on about 10 acres of the southeast corner of 13 Mile and Southfield roads. The Southfield Development Co. has requested approval from the city.

Action on the new center was taken on the motion of City Councilman Thomas Rowley who wants to visit the site before voting on the request.
