

Woolfenden Asks Dec. 31 Deadline For Con-Con Work

Con-Con delegate Henry L. Woolfenden (R-Bloomfield Hills) last week suggested that Constitutional Convention delegates set Dec. 31 as a deadline for getting proposed changes to the Constitution on April ballot.

Woolfenden's proposal, presented in a resolution submitted to the delegates in Lansing, allows about

2½ months less than the time suggested by President Stephen S. Nisbet (R-Fremont).

Nisbet repeatedly has asked that the convention put the finishing touches on its work by mid-March.

Birmingham voters apparently have split in their opinions concerning the proposed amendment to the city's charter to permit the City Commission to acquire downtown off-street parking lots for the use of the general shopping public.
