Michigan Bell Offers Headset To Aid Hearing

Michigan Bell Telephone Co. has announced a new telephone handset is available for persons with impaired hearing.

The handset, developed by the Bell Telephone Laboratories and the Western Electric Co., research and manufacturing arms of the Bell System, can be used with most types of telephones found in homes and offices.

The handset contains a volume control wheel in the underside of the handset midway between the mouthpiece and receiver. The control wheel, operated by a flick of the thumb, raises or lowers the volume of sound reaching the listener's ear.

The new amplifier handset is the latest improvement in telephony for persons with impaired hearing. Previously, a special telephone for those with impaired hearing was available. This feature was only offered in desk sets.

THE AMPLIFYING unit, through miniaturization, is in the handset itself. The new device will work with most telephones, including the Princess set, a Call Director phone for busy secretaries, and executives, and wall-type phones as well as desk sets.

Almost the exact duplication of a regular telephone handset, the new device is the same size as the ordinary one. The only visible difference in the two is the small, volume control.

It is estimated that eight per cent of the population has "demonstrable hearing loss."

The new amplifier handset will be joined later this year by a companion product which will amplify conversation to aid those with impaired speech.

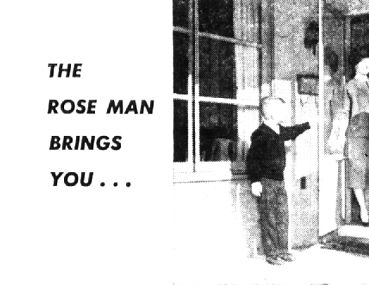
