As the students pass through the occupied hall they are crowded by a group of tall drafting tables in the route of passage.

Band rehearsal began about three weeks ago under the direction of Mr. Lively, East Hills band director who also teaches history. Mr. Lively remarked that the band showed prospects for meeting and going over the standards of the previous Lancer Band.

Language Labs are being anticipated by Mrs. Easter and Mr. Phillips, the school's French and Spanish teachers, respectively, and their language classes. Students will occupy booths where a tape is played, and they repeat what is heard.

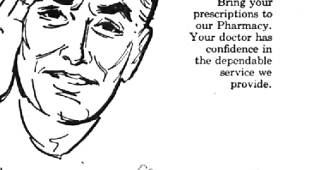

The end of the quarter has been marked by a flurry of activity as students begin to prepare for the quarterly exams. These exams are an accumulative review of the last two months' work and offer weight heavily in determining a student's quarterly mark.

This first quarter mark is important in many ways. An overall average of 85 percent will gain a student second honors; a 90 percent average, first honors. If a junior receives first honors this quarter and also received first honors for the fourth quarter of his sophomore year, he is eligible to become a charter member of the Phi Kappa Psi Fraternity.

Although there was quite a bit of interruption during the first few weeks of school, the students and teachers feel that there was no loss of time because of the building program. East Hills student body and staff all feel that the completed building will be well worth the distractions.
