that I be responsible for only 20 typewriters as a starter." Mr. Cookman worked out a system on the typewriters. Michigan at he took over all 60 of them. He talked the company into buying four extra ones. One of these, always in top shape, was kept in a company office for emergency replacement. The other three were on the repair circuit.

EVERY MONDAY morning Mr. Cookman started delivering three reconditioned machines to the company, picking up three used ones. In this way, each typewriter was reconditioned every 20 weeks. "I have a big repair bench set up in the basement, and I've bought a few special tools. I plan to spend about three hours every morning, five days a week, at the bench.
