

# Federal Funds Eyed For County Projects

Delos Hamlin, chairman of the county board of supervisors, has announced that Oakland County will seek an additional estimated \$1,800,000 in federal grants available through the new public works act.

The county would use the funds to complete three proposed projects at the county service center on a matching fund basis, Hamlin said.

THE COUNTY DPW has already filed intent to apply for \$4.8 million with the Federal Housing and Home Finance Agency which will handle the administration of the grants.

THE PROJECTS are an additional wing for the courthouse, now expanded juvenile facilities and drain and sewer utilities at the center on Telegraph Road.
