CITY OF BIRMINGHAM ORDINANCE NO. 601

An Ordinance to Amend Title X, Chapter 108, Section 10-8-10 of the City Code to Change the Annual Licensing Period for BUS DRIVERS.

The City of Birmingham Ordinance: Title X, Chapter 108, Section 10-8-10 of the City Code is amended to read as follows:

10-8-10. Issuance. Upon approval of the application, and upon payment of the license fees, the City Clerk shall issue a School Bus Driver's License to the applicant. Such license shall terminate on June 30th next following its issuance. Provided, however, that all licenses issued during the month of June shall be valid for the balance of the month and for the following year.

Ordained this 2nd day of December, 1963, by the Commission of the City of Birmingham, to be effective upon publication.
