Throughout the past year the hospital has been carrying out an 18-point program of physical and organizational changes in line with modern advances in safety practice.

Radiators were altered as a precaution against accidental burns; ventilators were installed in key areas.

Minor Vandermaede, associate director of the hospital and chairman of the safety committee, says further changes will be introduced when any new hazards are identified.

"Counting patients, visitors, students and nearly 3,000 employees," he says, "we estimate there are more than 6,000 people in the hospital each day."
