Marian Student Receives Model UN Award at U of D

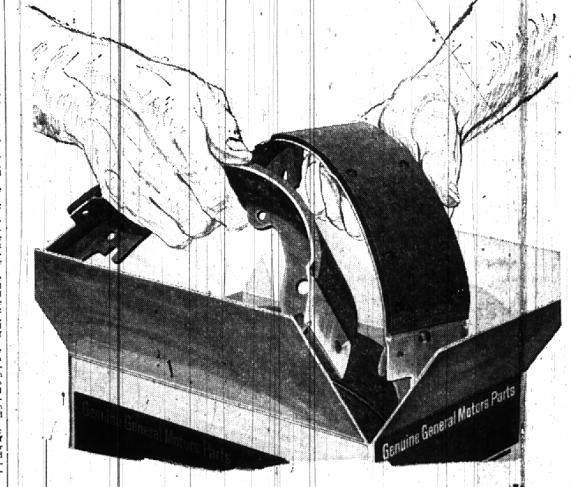
