HOLLYHOCKS—Remove dead & dying foliage and spray with BORDEAUX.

IRIS-Transplant this month. Take divisions from newer outside growth & water well.

DELPHINIUM—After flowering, cut back to 4 to 6 inches and fertilize with Gard-N-Gro, or Agrico 5-10-5. CHRYSANTHEMUM—For more fall blooms fertilize with 4-12-4, or 5-10-5, or dried cattle manure.
