

Traffic Death Slow-up Fails To Halt Record

Despite a surprising reduction of 39 traffic deaths in November, Michigan's count of 1,901 killed in the first 11 months indicates the 1964 total will probably range close to 2,100 to make it the third worst annual toll on record, according to provisional figures reported by the State Police. Higher losses were 2,115 in 1957 and 2,133 in 1941. Injuries and accidents for the year also are expected to climb to new highs to surpass the previous respective records of 126,806 and 261,794 set in 1963. The toll through November is 212 or 13 per cent greater than 1,689 for the first 11 months last year. The total of 1,885 for all of 1963 was matched this year on the Friday after Thanksgiving, with December, one of the worst months for traffic deaths, still to go.

NOVEMBER'S 155 death count was 20 per cent less than 194 in that month last year. Averages for the month were 151 for the five years of 1959-63, and 156 for the 10 years of 1954-63. High November was 219 in 1941 while the low of 87 came in 1942. It was only the second month this year to show a reduction in deaths compared with the same months a year ago. June had three fewer deaths.

More complete figures for October show 198 deaths and 12,787 injured in 24,034 accidents. These were increases of 19 or 11 per cent in deaths, 1,912 or 18 per cent in injured, and 3,333 or 16 per cent in accidents compared with the same month in 1963.

Accumulated 10-month figures included 1,746 killed and 114,067 injured in 222,109 accidents, respective increases of 17, 16 and 11 per cent compared with the same period last year.

Estimated mileage for the first nine months, the latest information available, was 28.1 billions, up nearly seven per cent over the same period in 1963, while the death rate of 5.5 per 100 million vehicle miles was increased by 10 per cent from 5.0.

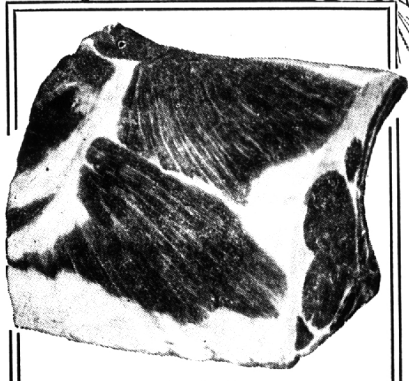

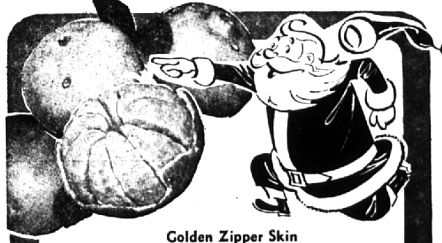
