Educator Vies For GOP State Senate Post

C. Ray Ballard, a business executive and educator from Huntington Woods, has announced his intention of running for the Republican ticket in the Sept. 1 primary.

The 21st senatorial district included the townships of Bloomfield, West Bloomfield, Commerce, North, Southfield, Farmington and Lyons and the cities and villages thereof, except Birmingham. It also includes Berkley, Oak Park, Huntington Woods, Pleasant Ridge and Royal Oak Township.
