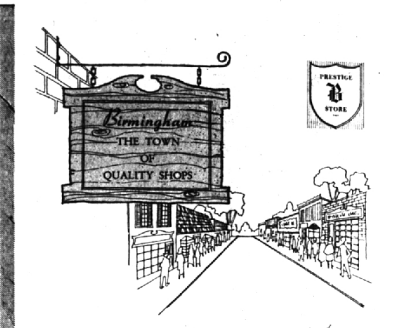
On USS Estes
